



# *International Mobility and Migration*

**M**igration and mobility are a major issue in terms of human, social and economic development for the countries of origin, transit and destination.

In this respect, the Sustainable Development Goals adopted by the United Nations for 2015-2030 call for the promotion of informed governance and management mechanisms to address migration challenges, aiming to "facilitate orderly, safe, regular and responsible migration and mobility of people, including through the implementation of planned and well-managed migration policies".

In this regard, Expertise France promotes an inter-sectoral and human rights-based approach to migration management and governance by supporting all stakeholders engaged in relevant fields.

## EXPERTISE FRANCE WORKS

### WITH NATIONAL AND LOCAL INSTITUTIONS

- Technical assistance in the development and implementation of national migration and asylum policy frameworks, and their mainstreaming into sectoral and local development plans and strategies
- Coordination and technical support to dedicated multistakeholder networks and promotion of South-South cooperation on transnational migration
- Information, awareness raising and sensitization on migrants' rights and status ; research and knowledge development

### WITH MIGRANTS

- Development and implementation of integration programmes in host countries and reintegration schemes in countries of origin
- Diaspora mobilization and inclusion in development and governance initiatives
- Promotion of human rights, access to basic services, and protection of vulnerable migrants including victims of trafficking

### WITH CIVIL SOCIETY

- Capacity building for civil society organizations in migrant assistance
- Networking, advocacy and support for institutional dialogues on migration
- Awareness raising among migrant communities through civil society-led initiatives

## RECOGNISED EXPERTISE: AN INTER-SECTORAL, MULTI-STAKEHOLDER AND MULTI-LEVEL APPROACH

Expertise France's intervention in migration seeks to maximize and upscale the positive effects of human mobility on development. The agency relies on:

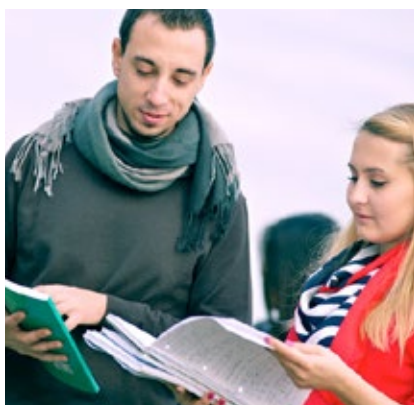
- **A pool of rapidly available experts:** French and international public or private expert missions, both short and long-term
- **In-depth diagnostics:** needs analysis (studies, research, consultative processes) for the design of migration governance programs
- **High-quality technical assistance:** project engineering and management, institutional support, real-time evaluation
- **Systematic capitalisation** to learn lessons and facilitate innovation.

The agency operates **in developing countries** and in **crisis and post-crisis situations**. It contributes to discussions on migration issues within **international and regional consultation frameworks**.

Expertise France mobilises European and Southern public expertise through its **extensive institutional network**. The agency plays a **federating role** by bringing together a wide range of stakeholders, including other French development agencies and operators, European cooperation agencies, international organizations, NGOs, etc., and thus have a growing pool of multidisciplinary expertise to implement large-scale projects.

Expertise France's Migrations Unit is made of a **team experienced** in different thematic areas of intervention, as well as in the management of bilateral and multilateral funds.

## OUR PROJECTS



### ***Sharaka - Promoting the mobility of skills and people***

2014-2017 – EU (€5M), FRANCE (€0,146 M), NETHERLANDS (€0,125M)

The aim is to support Morocco's migration, development and mobility policies through enhanced cooperation between European and Moroccan administrations. The project is part of the Mobility Partnership signed between Morocco and the European Union in June 2013. It is being implemented by Expertise France and involves OFII, the OECD and European administrations (Belgium, France, Germany, Italy, Netherlands, Spain, Sweden).



### ***AMMi – Addressing mixed migration flows in East Africa***

2015-2018 – €6M(EU)

The aim is to promote regional cooperation in order to protect vulnerable migrants and facilitate the fight against human trafficking and smuggling. The project is being implemented by Expertise France, in partnership with the French Ministry of the Interior, Italian Carabinieri, International Organization for Migration (IOM), Danish Refugee Council (DRC) and Regional Mixed Migration Secretariat (RMMS).



### ***MEEAfrica – Promoting innovative entrepreneurship in Africa***

2016-2018 – €1,7M (ICMPD - EU)

The aim is to assist the African diaspora in Europe in starting in their countries of origin – Algeria, Cameroon, Mali, Morocco, Senegal, Tunisia – innovative businesses with high potential of jobs and wealth creation. The project is being implemented by Expertise France, Campus France, and the Research Institute for Development (IRD) for France, and by GIZ for Germany.

**Expertise France** is the French public agency for international technical assistance. It aims at contributing to sustainable development based on solidarity and inclusiveness, mainly through enhancing the quality of public policies within the partner countries. Expertise France designs and implements cooperation projects addressing skills transfers between professionals. The agency also develops integrated offers, assembling public and private expertise in order to respond to the partner countries' needs.
